**ORDER**

THIS MOTION, made by the Applicant, Toronto Taxi Alliance Inc., for an interim injunction, was heard this day at 393 University Avenue, Toronto, Ontario, M5G 1E6.

ON READING the motion record of the Applicant, the Respondent and the Intervenor, the Taxi Workers Association of Ontario, and on hearing the submissions of the lawyers for the parties and the Intervenor, the parties having consented to paragraph 1,

1. THIS COURT ORDERS that the City of Toronto is hereby enjoined from acting upon or implementing Sections 545-140(A), 140(B)(2), 140(B)(3), and 545-149(G) pursuant to By-law 503-2014 as they may apply to Standard Taxicab Licence (STL) holders until the final

adjudication of the Application by the Superior Court of Justice so as to permit the issuance of an STL to the purchaser upon the sale or purchase of the standard taxicab.

2. THIS COURT FURTHER ORDERS that in the event the By-Law referenced at paragraph 1 is upheld by the Superior Court of Justice, no rights are conferred by this Order that would entitle a party who acquires an STL after June 30, 2014 to be treated as if they had been an STL holder prior to July 1, 2014.

3. THIS COURT FURTHER ORDERS that the Taxi Workers Association of Ontario is granted leave to be added as a party respondent with the full rights and responsibilities thereof pursuant to Rule 13.01.

4. THIS COURT FURTHER ORDERS costs in the amount of \$12,500.00 to be payable in the cause vis-a-vis the Applicant and the City of Toronto.

5. THIS COURT ORDERS that costs of today's motion in relation to the Intervenor, if any, are reserved to the application judge.
